Declaro para os devidos fins, nos termos do art. 26, caput, inciso IX, do Decreto nº 8.726, de 2016, que a **FUNDAÇÃO AMAZÔNIA SUSTENTÁVEL - FAS**, Fundação de Direito Privado, inscrita no CNPJ/MF 09.351.359/0001-88 e com sede na Capital do Estado do Amazonas à Rua Álvaro Braga, 351 – Parque 10 de Novembro, neste ato representada pela Superintendente de Desenvolvimento Sustentável de Comunidades, a Sra. Valcléia dos Santos Lima Solidade, brasileira, natural de Santarém/PA, casada, Gestora de Políticas Públicas, portadora do RG [REDACTED] e CPF [REDACTED] residente e domiciliada na [REDACTED] e seus dirigentes não incorrem em quaisquer das vedações previstas no art. 39 da Lei nº 13.019, de 2014. Nesse sentido, a citada entidade:

1. Está regularmente constituída ou, se estrangeira, está autorizada a funcionar no território nacional;
2. Não foi omissa no dever de prestar contas de parceria anteriormente celebrada;
3. Não tem como dirigente membro de Poder ou do Ministério Público, ou dirigente de órgão ou entidade da Administração Pública da mesma esfera governamental na qual será celebrado o termo de fomento, estendendo-se a vedação aos respectivos cônjuges ou companheiros, bem como parentes em linha reta, colateral ou por afinidade, até o segundo grau.
3. Não teve as contas rejeitadas pela Administração Pública nos últimos cinco anos, observadas as exceções previstas no art. 39, caput, inciso IV, alíneas “a” a “c”, da Lei nº 13.019, de 2014;
4. Não se encontra submetida aos efeitos das sanções de suspensão de participação em licitação e impedimento de contratar com a administração, declaração de inidoneidade para licitar ou contratar com a Administração Pública, suspensão temporária da participação em chamamento público e impedimento de celebrar parceria ou contrato com órgãos e entidades da esfera de governo da Administração Pública sancionadora e, por fim, declaração de inidoneidade para participar de chamamento público ou celebrar parceria ou contrato com órgãos e entidades de todas as esferas de governo;
5. Não teve contas de parceria julgadas irregulares ou rejeitadas por Tribunal ou Conselho de Contas de qualquer esfera da Federação, em decisão irrecorrível, nos últimos 8 (oito) anos; e
6. Não tem entre seus dirigentes pessoa cujas contas relativas a parcerias tenham sido julgadas irregulares ou rejeitadas por Tribunal ou Conselho de Contas de qualquer esfera da Federação, em decisão irrecorrível, nos últimos 8 (oito) anos; julgada responsável por falta grave e inabilitada para o exercício de cargo em comissão ou função de confiança, enquanto durar a

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, FAS Fundação Amazônia Sustentável (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

### **Consequences of changing your mind**

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

### **All notices and disclosures will be sent to you electronically**

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

We will bill you for any fees at that time, if any.

### **To withdraw your consent with FAS Fundação Amazônia Sustentável**

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to [juridicoamazonia2022@gmail.com](mailto:juridicoamazonia2022@gmail.com) and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

### **Required hardware and software**

### **Acknowledging your access and consent to receive and sign documents electronically**
